COURSE DESCRIPTION

The Health Education Program is scheduled as a 1 marking period course. All students must be enrolled in Health Education every year of enrollment as a requirement for graduation by the State and Board Policy. 10th Grade will take a driver's education course in replace of a health class.

Health Grade: You must earn a 65 or higher to pass for the year.

COURSE OVERVIEW

This course will consist of

- **9th Grade:** Foundations of human growth and development, responsible personal behavior, interpersonal relationships, family life, parenting, chemical health education,
- **10th Grade:** Getting ready to drive, basic car control, natural laws and car control, performing basic car maneuvers, negotiating intersections, negotiating intersections, adverse conditions, effects of driving condition on risk taking, preparation for state qualifying exam for drivers,
- **11th Grade:** Nutrition, personal health, anatomy and physiology of body systems, mental and emotional health, chemical health education.

- **12th Grade:** Basic first aid, common accidents in shops or home, infections from bites and wounds, ill effects of extreme heat and cold, common accidents at home, hazards at vacation homes, other problems requiring first aid, health maintenance and interrelationships, chemical health education, environmental health.

N.J.S.A. 18A:35-4.7 Parent's Statement of Conflict with Conscience


